PLEASE NOTE:

- All references to the Brockton MA Ribbon Signal Transfer Point (STP) switch are associated with CLI code BRTNMACO22W and will not be repeated throughout the notice.
- All references to the Brockton MA Oracle EAGLE STP switch are associated with CLI code BRTNMACO26W and will not be repeated throughout the notice.
- All references to the Cambridge MA Ribbon STP switch are associated with CLI code CMBRMABE22W and will not be repeated throughout this letter.
- All references to the Cambridge MA Oracle EAGLE STP switch are associated with CLI code CMBRMABE26W and will not be repeated throughout this letter.

Description of the Planned Network Changes:

Verizon will make changes to its Signaling System 7 (SS7) network and services resulting from its consolidation plan. The Brockton MA Ribbon STP, located at 180 Court Street, Brockton, Massachusetts, 02302, will be removed from service and the SS7 traffic will be moved to the Brockton Oracle EAGLE STP, located at the same location. Also, the Cambridge MA Ribbon STP, located at 210 Bent Street, Cambridge, Massachusetts, 02141, will be removed from service and the SS7 traffic will be moved to the Cambridge MA Oracle EAGLE STP, located at the same location. All SS7 traffic to be migrated includes, but is not limited to, InterLata (Access/FG/CLEC/IXC), wireless traffic and paging traffic.

Description of Reasonably Foreseeable Impact of the Planned Changes:

SS7 Service providers with SS7 link terminations in Verizons Brockton MA Ribbon STP and Cambridge MA Ribbon STP will be contacted prior to the rehome to confirm creation of new link terminations in the Brockton MA Oracle STP and Cambridge

MA Oracle STP. Access Service Requests (ASRs) that include no physical design changes need to be created and submitted by May 1, 2024 to meet the May 31, 2024 cutover date to the new Oracle EAGLE STPs. Please use Project Code: BRTNCMBR26W.

SS7 service providers and any other affected carriers will need to alter their SS7 transport, OffNet services arrangements (services obtained from third parties) and/or Gateway services in order to access or continue serving customers served by offices that are currently homed to Brockton, MA and Cambridge, MA Ribbon STPs.
